# IMPLEMENTING GUIDELINES FOR PATCOMC MEMBERS BENEFIT FUND (DAMAYAN)

#### **Article 1 AUTHORITY**

Pursuant to General Assembly Resolution Number 04-03 dated March 7, 2003 during the 13th Annual General Assembly, the following guidelines shall govern the implementation of the PATCOMC-DAMAYAN FUND (PDF).

#### **Article II OBJECTIVES**

The objective of PDF is to express the cooperative's social responsiveness in the light of unity and cooperation by providing an environment where each member can mutually help and benefit.

### **Article III SPECIFIC OBJECTIVE**

At its launching, the specific objective of the PDF is to provide financial assistance to the bereaved families of deceased PDF members.

### Article IV THE PATCOMC-DAMAYAN FUND COMMITTEE

- Section 1. The Social Service Committee shall be responsible on the management of the PDF. The committee shall be composed of three (3) members to be appointed by the Board of Directors during its organizational meeting, who shall serve for one (1) year, unless otherwise removed or disqualified.
- Section 2. The committee shall be tasked to do the following
  - 2.1. Act on application for membership and change of beneficiaries
  - 2.2. Facilitate claims of the bereaved family and/or initiate processing of claims
  - 2.3. Determine the amount of claims due
  - 2.4. Delivery of assistance, in coordination with the Manager.
  - 2.5. Review the provisions of this document to improve the services and coverage of the PDF
  - 2.6. such other duties which may be assigned by the board.

### Article V MEMBERSHIP and COVERAGE

- Section 1. Membership is voluntary and open to all regular and associate members of PATCOMC.
- Section 2. Interested PATCOMC member shall accomplished application form and submit same to the Social Services Fund Committee Coverage starts upon receipt of initial contribution.

### Article VI BENEFIT

- Section 1. PDF shall grant financial assistance to the bereaved family of deceased PDF member, through the recognized beneficiary.
- Section 2. The amount of financial assistance is FIFTY THOUSAND PESOS (Php50,000.00), provided that the member is continuously contributing till time of death. Otherwise, the Social Services Committee shall determine the amount to be granted which shall be lower than Php50,000.00.

### Article VII CONTRIBUTIONS

- Section 1. A member shall contribute Php600.00 yearly through:
  - Interest on capital (IC) / Patronage refund(PR)
  - Cash payment (one time) or Salary deduction
  - Savings withdrawal (R1)
- Section 2. Coverage ceases after three (3) consecutive months of non-payment of dues and resumes after payment of arrears.

## Article VIII AMENDMENTS

Any amendment to these guidelines shall be approved by the Board of Directors, upon recommendation of the Social Services Committee, and shall be implemented thirty (30) days after publication.
